Reflections on 2024 (Outputs and outcomes)

This has been a very busy year for the forum steering committee with members working across a range of projects that aims to support pain and palliative care nursing practice.

Podcasts

This year the forum steering committee members have developed a series of education podcast exploring different topics in pain and palliative care nursing. We have developed the following podcasts that are currently hosted on the forum webpage:

- Introduction to Neuropathic Pain joint with Neuroscience forum
- Delivering person care in palliative care
- Procedural related pain

We have also run two podcasts in combination with the Nursing standard, this included an introduction to essential pain management framework and nursing role in supporting those with pain. We have three further podcasts in development that will focus on pain management in paediatric population, having difficult conversations and bereavement.

Blogs

We continue to publish a range of blogs on topics relating to pain and palliative care nursing and the work of forum members. This year we published blogs around our activities at RCN congress.



Pain Assessment in Learning Disability Project

Sandra Campbell continues to lead the work that was approved by FGG in 2023. This is a national project that brings together nursing professionals from across the four nations to develop a tool kit around pain assessment in those with learning disabilities. The project is developing as planned and due to be launched at congress 2025.

Getting it right every time- Fundamentals of Nursing care at the end of life

Ola Isaiah has been leading this national project that has engagement from stakeholders from across the four nations. This project is focused on developing a digital resource regarding the fundamentals of palliative and end of life care. This builds on the previous document "Getting it right every time-Fundamentals of Nursing care at the end of life" and aims to expand on this a provide an interactive resource that all nursing staff can access. This work is expected to be completed in 2025.

Assisted Dying

The forum steering committee are actively involved in the wider work of the RCN regarding the assisted dying position statement and guidance documents. Martin Galligan and Sandra Campbell have been working together on updating the "what to do when someone asks about assisted dying" document and representing forum membership at the RCN working groups. It is our hope that the updated guidance document will be released in 2025.

Congress attendance

This year the forum steering committee were extremely busy at congress with a resolution led by Sandra Campbell that was focussed on improving access to controlled drugs at end of life for those in care homes. Sandra continues to work on this resolution as it was passed by congress and has moved on to the next stage of lobbying government. Martin and Rachel run a learning and wellbeing event regarding introduction to pain assessment and management. This was a well-attended and positively reviewed event that has resulted in a joint podcast with the Nursing Standard. The forum also hosted a meet the forum session and attendance at the world café.

UK Career Framework for Pain Nurses

Martin Galligan has been leading the work of this project and this is now due for review. A national survey on the pain CNS role has been undertaken and will inform the next steps of this project. This is anticipated to be completed in 2025.

Forum Conference

The forum will be running their first conference in March 2025 and have been working with the events team in the planning of this. Martin has been leading this project and arranging a range of speakers that cover a variety of topics in pain and palliative care nursing.

Stakeholder / link nurse group

The forum continues to have a very active link nurse and stakeholder group. This groups helps to inform the work of the forum and supports the steering committee in the development of projects.
