

## RCN Forum Annual Report 2024

Forum Name: Women's Health

#### Introduction:

The Women's Health (WH) forum covers a wide range of conditions and complements the work of other forums, enabling plenty of opportunities for collaborative work. We aim to provide women's health nursing expertise to the RCN and help shape national policy. All forum activities align with the RCN strategy, including working across the UK, taking account of the requirements in each of the devolved countries.

### Membership of the forum

Total forum number: 5848 an increase of 7.54% in the last 12 months. Social media engagement has also increased, we had 1,853 X followers (before disengagement) and our Facebook page now has 1380 members of whom 260 have actively engaged with the group during the year.

### Reflections on 2024 (Outputs and outcomes)

The forum met in February 2024 to discuss strategy and agree a workplan. Guided by the strategic aims of the Governments' Women's Health Strategy, we agreed to prioritise health needs of vulnerable women, campaign for the RCN membership to back the call for decriminalisation of abortion care, build on the success of our December 2023 RCN conference and extend our profile through the use of social media, blogs, webinars and collaborations.

The forum has had an incredibly productive and successful year, and the following report outlines the breadth of activities that we have engaged in.

#### Webinars and Conferences



The Women's Health Conference 2023 took place in December and was attended by nearly 100 delegates. The highly successful and well evaluated event had as its theme *Inequalities in Women's Health - seizing the cusp of change* and benefitted from presentations from forum members Emma Ayling, Katharine Christopher, RCN fellow Debby Holloway and RCN President Sheilabye Sobrany.

The forum has presented a successful webinar to launch the SRH competency framework for caring for women in prison on collaboration with the Justice and Forensic Nursing forum. This framework was presented at the BASHH conference in 2024.



Vice-Chair Charlotte Glynn presented an update on abortion care at the British Society of Abortion Care Providers conference in October 2024.

Debra Holloway and Ruth Bailey contributed to the *Menopause*, beyond the foundations conference in November 2024.

The forum will host its annual conference in December 2024, the programme includes presentations by forum members, a live debate, and an address from Dame Lesley Regan the Women's Health Ambassador for England.

## Congress 2024

Micheal Nevill successfully presented a Congress resolution calling for the RCN to add its support to the campaign for the decriminalisation of abortion. After robust debate, the item was passed to Council for action, who mandated the Professional Nursing Committee to create a new position statement. The decriminalisation of abortion position statement was agreed by Council November 2024 and is due to be published and distributed in early December.





The forum collaborated with the Management and Leadership Forum event on the *Definition of Nursing* which explored practical ways for members to use the updated definition of Nursing.

The three Voting members, Ruth Bailey, Cyzel Gomes and Michael Nevill contributed to the World Café Forum event, singing in solidarity, networking at regional events and speaking on the podium.

# Forum Highlights

We are proud of the projects we have completed, and our ongoing commitment to marginalised women and our key achievement in updating the RCN position statement supporting the decriminalisation of abortion through our resolution at Congress which goes to Council for approval in November 2024.

We are also delighted that our forum committee member Charlotte Glyn was awarded RCN Forum member of the year, and our former chair and RCN Fellow Debra Holloway was awarded MBE for services to women's health.



### Engagement with wider membership

In 2024 the forum has established and supported the development of a Gynaecological Nurses clinical leadership network. Led by forum member Emma Ayling, it now has 180 members and meets 6 times a year to discuss policy and listen to a variety of speakers presenting on women's health. The network has its own social media accounts and serves as a network to the wider community.

The forum supported the RCN campaign to get the vote out in response to the NHS pay award. The forum chair participated in walking the wards with the RCN General secretary in September 24.
