#### ROYAL COLLEGE OF NURSING RESPONSE TO DEPARTMENT OF HEALTH CONSULTATION ON TRANSPOSITION OF THE REVISED MUTUAL RECOGNITION OF PROFESSIONAL QUALIFICATIONS DIRECTIVE

The Royal College of Nursing has responded to a number of consultations in relation to the health aspects of the draft Professional Qualifications Directive during its adoption at European level and since then its implementation in the UK, including a specific consultation on language controls. This brief response will focus on any outstanding issues in relation to nursing and the implementing regulations.

Q1. Are there any further legislative amendments, other than those set out in the draft *European Qualifications (Health and Social Care Professions) Regulations 2015,* which you think are required as a result of the changes to the Directive?

# Q5. Do you think there are any potential issues with the introduction of the EPC in relation to the health care professions that have been selected by the Commission?

It will be important to review the uptake of the virtual European Professional Card for nurses after a period of implementation as it introduces a new process and timescales for recognition.

#### **Q6.** Do you agree with the Department's interpretation of what should constitute an alert in relation to healthcare professionals?

The RCN would want clarity that an alert to other regulators would not be triggered if a registrant of the Nursing and Midwifery Council had briefly lapsed from registration for late payment of fees.

### Q7. Do you think it would be helpful for the Department to provide healthcare specific guidance for the regulatory bodies to complement the BIS guidance?

Given the patient safety implications for health professions it is important to have specific guidance for this sector.

### **Q8.** Is there anything that you would like us to include in healthcare specific guidance?

It would be useful to have more specific guidance in relation to "temporary and occasional" practice in a member state including a future review of whether this route to registration increases and the impact on language competency, since nurses using this route will self-declare and not be required to submit evidence to the NMC or take a test, unlike those using the permanent routel

Employers also need to be made aware of this difference if employing someone through this temporary route.

# Q9. Are there any protected characteristics that you feel may be effected, either positively or negatively, by these changes?

# Q10. Are there any potential monetary impacts (either positive or negative) that you think we need to be aware of?

We would anticipate some costs to the Nursing and Midwifery Council in implementing the new arrangements.
